Benin

18 reports: 5 killings / 5 survivors / 7 missing / 1 grave desecrations

Survivor	On August 4 th 2017, a 13-year-old girl with albinism (name withheld) narrowly escaped abduction and was found unhurt the following day in Dogbo in the southwest of Benin. According to the victim's cousin, V.G., she was just leaving the marketplace with one of her sisters and was in the neighborhood of Dogbo Zaphi public primary school when the kidnappers approached frightening the victim's sister away and abducting her in a black Ford Focus with the license number AY 4078. The police were immediately alerted and launched a large patrol of the surrounding area. Under intense pressure, the kidnappers were forced to release the victim in a bush where she spent the night. The following morning she found help and was reunited with her family at the Dobgo's Police station with the General Director of the National Police. All 3 suspects who committed the abduction are Beninese from Dogbo and have been arrested by Commander CIE APLAHOUE and his team and will be presented to a public prosecutor.
	On July 13, 2013 a 20 year old man with albinism known as F.M.H. was deceived, drugged, kidnapped, killed and mutilated in his homeland of Benin. F lived in the community of Lalo in south-western Benin, where he was learning to become a nurse in one of the hospitals at Lalo Centre. F had a cousin



named P.H. who lived in Koudjon Centre, a small village near Lalo. Both boys had grown up together in the same hamlet of Ouinsouhoué.

On that fateful day, P approached his cousin with albinism in order to deceive him, saying that he'd found a high paying job for him in downtown Cotonou, and that the boss wanted to meet right away. F showed no hesitation and after a 3 hour ride, they went to wait for the so-called boss in a bar. Here F was drugged and kidnapped to Porto-Novo, the country's capital city, where he was killed, and parts of his body removed. When P returned home to Lalo alone, everyone started asking for F. Pascal kept insisting that he had not traveled anywhere with F. Since many had seen them travelling together, people started threatening him to tell the truth. In an attempt to conceal the truth and silence the family, he decided to consult various witchdoctors to make him amulets.

Finally he and his three accomplices went to consult one of the visionaries of the Celestial Churches of Christ. He told him the whole story and begged him to mystically silence everyone about the murder in exchange for a lot of money. The visionary left his house briefly and called the police, who arrived quickly. The criminals tried to escape but the police shot one of them and all four were arrested and placed in custody. Of the four, one was released when it was discovered that he was the younger brother to one of the criminals and had nothing to do with the murder. The other three were placed in the prison in Lokossa and are serving their sentences.

Killing

On March 23, 2019, a 45-year-old man with albinism by the name of A.A. went missing in the city of Abomey, Zou Department, Benin. The victim was a well-known joiner (carpenter) who lived in the A's home and had his joinery business opposite the D.T. Much to the dismay of his family, the victim's younger brother may have been involved in his disappearance. According to a cousin, A had some work to do for an old man who had called him in the morning of Saturday, March 23, indicating that the door locks had been purchased and that he should come to make the repairs. A has not been heard from since. The old man was questioned over the disappearance but denies that A met with him that day. F.H., founder and chairperson of Beninese Albinism NGO has raised the alert, asking anyone who has any suspicions about A's destination that day to inform the police or the nearest local authority. He concluded by saying: "I pray we find A unharmed for the sake of his family and the nation. I appeal parents to look after their children with albinism. I also warn adults with albinism against going unaccompanied to a meeting even if they know the person who invites them to that meeting."
In September of 2018, a 50-year-old woman with albinism by the name of D.C.K. ends up dying of skin cancer after which her lifeless body was decapitated by a family member at her burial in the woods near her family home in the community of Allada, Atlantique Department, Benin. Over the span of multiple unknown dates throughout the course of her life, the deceased had survived numerous abduction attempts and other inhumane cruelties at the hands of her family. D.C.K. had always been disowned by her father's family who compared her



to a white monster along with many other punishing psychological abuses. She never did manage to move past these cruelties and build a family of her own. At one-point she was very sick with wounds all over her body and finally decided to seek assistance from her mother's younger sister, hoping for a more supportive response.

Grave Desecration

Tragically, and to her great surprise, she was ill-treated by her aunt as well, being forced to cook despite her poor vision and deteriorating health. One day while cooking, a fire broke out in the kitchen due to her only having sight in one eye which she suffered from low vision, she didn't immediately notice the fire and was nearly burnt alive. Thankfully, she was rescued by some neighbours. To make life worse, her aunt colluded with a witchdoctor to get rid of her for good. The aunt told D that she knew of a witchdoctor who could heal her but that the treatment consisted of pouring boiling water over the left side of her face. This was pure torture for the victim who screamed for help while being overpowered by the perpetrators. She lost half of her left ear during this so-called "cure" ritual, and the skin on her face had all but disappeared and became infested with maggots. Upon arrival at hospital the doctors denounced the so-called treatment, describing it as Machiavellian. In September of 2018, D died of skin cancer.

Her body was immediately apprehended by the family who refused to give her a decent funeral, saying that she did not deserve a coffin or a grave in a cemetery. One of the K. family members publicly declared that he needed her head because, since childhood she had been very lucky, having escaped their many attempted kidnappings. Nestor, one of the deceased cousins, insisted on participating in the burial in the bush in

	ALLADA. Following the funeral, Nestor told police that the	
	body's head had been removed before it was buried. The	
	police warned him against pushing the case further for fear that	
	he may be killed by the family. They went on to tell Nestor that	
	this was a family matter and that there was no need to "make	
	noise" about the body parts that had been removed since the	
	victim was already dead.	



Botswana

4 reports: 3 survivors/1 killing

	In September of 1998, a 27-year-old woman with albinism (name withheld) narrowly escaped a second plot against her life. The incident took place at Kanye, her native village in Southern Botswana. Although the victim was a primary school teacher in the city of Jwaneng, Botswana, she was pregnant and staying in her native village at the time. On this near fateful day, her young brother encountered three guys in the village night club who knew S.
<u>Survivor</u>	They offered him some beer to get him drunk, hoping to manipulate him into joining their murder plot against his sister. Fortunately, he sensed something was wrong and secretly managed to replace the beer with water while pretending to be drunk. The guys asked him: "Where is your sister, the albino teacher?" "Your sister could actually make the deal: She is albino and pregnant!" "We want her flesh!". The victim's brother lied, telling them she was teaching in Jwanenge city but would be home for the weekend and that they could find her then. When he got home from the club that evening, the victim's brother told her everything and warned her to leave immediately to Jwanenge city for her safety. After that incident, S stayed in the city for a long time.



<u>Murder</u>	 K.M. (34 year-old woman): On Wednesday 24 May, 2023 K was allegedly stabbed to death by her husband G.M. in the presence of a psychologist at the women's shelter in Gaborone. [Editorial note by AAN: Based on Facebook posts on the situation, this case appears to be a potential case of GBV/IPV but we also recognize the potential of intersectionality and have recorded the case for that reason. Burkina Faso

9 reports: 2 killing / 6 survivors / 1 asylum

<u>Killing</u>	On August 14, 2012, a 12-year-old boy with albinism was killed in Gaoua, Burkina Faso. Witnesses report that the body was found with his head and genitals removed. (Trusted Source: To protect our sources, we have withheld their names from this publication, <i>GAOUA, BURKINA FASO – 12 year old boy with albinism killed</i> , on Wednesday, August 15, 2012)
<u>Trafficking</u>	On April 18th, 2021, Dr. P.K. , an American physician originally from Kenya, was an eye witness at the Nairobi airport to three aggressive African men being allowed to transport a young boy with albinism out of the country without a passport. He said the men had come from Tanzania and were headed to Ouagadougou, in Burkina Faso and that they used loud, offensive language as the airline attendant asked for the missing passport – they had three passports and none for the child. Dr. P.K. is now convinced that the three-year-old boy with albinism is no longer a baby headed to a loving family, but a sacrifice at some altar of a cruel witchcraft ceremony.

<u>Burundi</u>

41 reports: 23 killings, 13 survivors, 5 grave desecrations

Killing	 On February 1, 2022, it was reported that the dismembered remains of a 4 year old boy with albinism were found. It was also reported that three people drove up in a car and abducted the boy off the street on the Saturday as he was playing with other children on the outskirts of Burundi's biggest city Bujumbura. The kidnappers drove the victim, whose name was given as A., somewhere 230 (145 miles) kilometres to Cankuzo province where he was killed and dismembered, said the albinism organization, ASF, and a local administrative official. "A was killed, then his executioners cut off his arms and legs before removing the bones and sharing them around. His remains were thrown in a forest," said the official, who requested anonymity. <u>Survivor</u>	On October 6^{th,} 2015, a 10-year-old girl with albinism (name withheld) miraculously survived a brutal attack at her home in Busoni town, in the province of Kirundo, in Muyange-Gisozi, Northern Burundi. Men armed with machetes attacked the family of G.N. & N. who were accommodating her. Fortunately, neighbours managed to intervene and help bring a premature end to the

	attack. The victim sustained injuries to the head and shoulder and underwent intensive treatment at Kanyinya Hospital in Kirundo. The criminals escaped before being identified.	
<u>Grave</u> Desecration	On the night of March 6, 2022, the grave of girl with albinism was desecrated. The victim's remains were also taken by unidentified perpetrators.

Cameroon

12 reports: 3 killings, 2 survivor, 6 asylums, 1 grave desecrations

	In September 2021 , it was reported that F.F. living in Bafassam/Bafousam, western region in Cameroon was presumed kidnapped after he disappeared from traffic. The victim's remains were reportedly found on August 29, 2021, also in Bafousam, with several body parts missing. He was buried by strangers in the wild. (Trusted Source: To protect our sources, we have withheld their names from this publication, <i>BAFASSAM/BAFOUSAM, CAMEROON</i> – male, kidnapped & dismembered, September 2021.)
<u>Killing</u>	In September 17, 2021, a 40 year old man whom was a trader in the A market in Bafoussam was killed. Police officers from the Bafoussam 1e police station indicate that F's body was discovered in the same arrondissement, mutilated, abandoned in a brush. The body was reportedly amputated from organs taken by the alleged murderers.
	The chief warrant officer, deputy commander of the Djeleng 5 gendarmerie brigade, quoted by the newspaper, indicates that further research is underway. They will allow the investigation into this atrocious assassination to evolve as quickly as possible.

<u>Survivor</u>	In 2013, a mother and her infant with albinism began the process of seeking asylum in France as she feared for the life of her child in Cameroon where members of her community attempted to kill the baby for ritual purposes during local elections.
<u>Asylum</u>	On December 23, 2015, a man with albinism (name withheld) from Cameroon was granted refugee status in UK. (Trusted Source: Interviews with UTSS)



Congo Brazzaville

7 reports: 7 killings

<u>Killing</u>	3 women were killed with machetes while working in their fields deep in the forest and their bodies were never recovered. No arrests have been made in connection to any of these murders. This unprecedented wave of attacks have created a climate of terror among PWAs and their families.

Democratic Republic of Congo (DRC)

74 reports: 18 killings / 37 survivors / 1 missing / 11 grave desecrations / 7 asylums

<u>Killing</u>	On Wednesday, February 1, 2023, J.K., a 5 year-old child's mutilated body was found in Kitaho in the village of Chambombo, the territory of Kalehe in South Kivu. J was killed when he was kidnapped from his family's home by thugs who could be identified. The thugs locked the child's family in their house when they kidnapped and murdered the little boy. J.B.B. known to the victim and also an activist of the Association OBAPG-RDC called on security forces to investigate the murder.



Egypt

1 report: 1 asylum

<u>Asylum</u>	On Friday, September 16, 2011 , (name withheld), a 28 year old man with albinism from Egypt told journalist S.B. about his life in Egypt and his newfound asylum in New Zealand. He contrasted the profound discrimination facing people with albinism in Egypt with the amazing and equal opportunities he has found in New Zealand. The man's lawyer said: "He was seriously maltreated at multiple levels including such things as deliberate cigarette burns from supposed educators The hostility toward him was serious at best because of his Albinism. He has now been able to both marry and continue his studies. He is one of the nicest and most considerate people I have met in a long time and doing very well." The man says; "I want to be a professor in the university. The first time I ever got a salary was here in New Zealand. I can support myself and my research. I don't want to go back to Egypt, not even for a visit." <u>Gabon</u>

2 reports: 2 survivors

<u>Survivor</u>	ALBA, an association for people with albinism in Gabon reports that on Sunday March 6, 2022, they received a report that a boy with albinism, (age not reported) by the name of D. had survived an attempted kidnapping, a day earlier on March 2nd, 2022. The kidnapping was intercepted when his mother, alerted by the cries of D came out to find her son in the hands of a stranger who was trying to flee with the child. Frightened by the cries of the baby and his mother, the perpetrator released the child and fled.

<u>Ghana</u>

3 reports: 1 killing / 3 survivors

<u>Killing</u>	On February 17, 2015, the lifeless body of a 35 year old man with albinism by the name of K.Y. aka A. was found at the entrance of Pastor E.A.'s residence in Owoakra, Boketey, under Amanase in the eastern region of Ghana. According to the pastor's wife, G.A., her husband ran off shortly after the death of K and she has not heard from him since. Unfortunately, the police have not been responsive to crimes committed in this area and allowed Pastor A to escape without questioning. Since that time however, police commander S.P.T.Y. of Suhum police station announced that because of the public interest whipped up by media related to the death of K.Y., the homicide unit at police headquarters in Accra had taken over the investigation.
<u>Survivor</u>	On January 1, 2023, a 16 year old boy with albinism from the town of Garu in the Upper East region of North Ghana, was playing football with his his teammates while celebrating the new year when the perpetrator approached him on a motorbike. The perpetrator pleaded with the victim to go with him to get his bicycle from a nearby neighborhood and bring it back to where they were playing football since he couldn't ride two bikes at once. The survivor consented, but when they reached the said neighborhood, the perpetrator didn't stop. When the survivor protested, he insisted he stops at the next neighborhood. Upon reaching the next neighborhood, the perpetrator still refused to stop despite the survivor's protests, so he jumped off the bike, and in an attempt to flee, he met a lady and narrated the story. Little did he know, she was the main perpetrator and had a syndicate following them on a motorcycle. Upon arriving, he verified their participation in the attempted abduction.

Guinea

16 reports: 5 killings / 6 survivors / 5 asylums & other refuge cases

<u>Killing</u>	On a Sunday in September of 2010 , at the area of <i>La Carrière,</i> in the town of Matam, district of Conakry, the body of a PWA was found with the eyes missing— very likely removed with a knife. According to our source, the unnamed PWA used to wander daily in that area with some friends, looking for their daily bread. The victim's life is made up of begging at the big market of Matam's main station and on the streets of the Capital City. One morning his lifeless body was found laying on the sidewalk.
<u>Survivor</u>	On May 17, 2017 a four-year-old girl with albinism (name withheld) narrowly escaped a ritual tragedy after being rescued from 4 men who had abducted the victim in the country village of Damankania, in the Sinanya district of Yabara, Guinea. The suspected traffickers kidnapped the little girl in front of her mother at their home. Her father Salif Camara explains: "a young man got out of a vehicle that was parked in front of my compound and snatched our daughter. My wife who was on the scene asked the kidnappers where they were taking her. Without answering they drove off with little the child. My wife shouted for a motorbike taxi to chase the kidnappers. I immediately alerted the Commander of the Gendarmerie (police) who deployed his team and managed to capture the vehicle. Of the 4 assailants, 2 succeeded in escaping and the other two were arrested." Accused of

<u>Survivor</u>	 trafficking of a person with albinism, a man by the name of Mohamed Conté and a woman named Aissata Bangoura were arrested on May 17, 2017, by the Services of the Territorial Gendarmerie (Police) of Kindia. When including, the abductor named Mohamed Conté admitted that he was a witchdoctor who came to visit another older witchdoctor known as Doubayadi who was also the father of his colleague Aissata Bangoura. <u>Asylum</u>	On Thursday September 20, 2018, a woman with albinism in her mid-thirties from Guinea was granted subsidiary protection in France. The woman first came to France on a student visa which was denied renewal some years ago. Faced with the risk of deportation, she has now been granted a subsidiary protection due to her albinism. Ivory Coast

30 reports: 9 killings / 13 survivors / 4 missing / 2 asylums / 2 abandoned

<u>Killing</u>	On June 30, 2017, the lifeless body of a 3 year old boy with albinism by the name of S.O. was found in a 1 meter deep abandoned well situated behind the town hall of Kani, in the ward of Damasso, in the north west of Ivory Coast. According to first testimonies gathered by M.C., this case was not an accident and it appeared that the boy was tragically murdered for ritual purposes and his body thrown in the abandoned well. <u>Survivor</u>	In late June of 2017, a woman with albinism had her 15 month old infant, who did not have albinsm by the name of C.A.K., kidnapped from their home in Ivory Coast by a pigmented woman from Benin. The police in Arrah, in the east of the country, found the Beninese woman named Nadège Dassia after she had stolen the child. After four years of trying to give birth to her own child, the abductor passed herself off as a soap seller which easily enabled her to enter the bedroom of the absent mother and abduct the baby. After fleeing the house with the infant in a taxi heading towards KOTOBI (in east-central of Cote d'ivoire, subprefecture of Arrah), the police were allerted and managed to catch the pair,

<u>Survivor</u>	arrest the kidnapper, rescue the infant and reunite the mother with her child. <u>Asylum</u>	 29 year old woman with albinism (name withheld) whom is also a mother of a 13 year old daughter and an 8 year old son who, just four days after narrowly escaping a second attack due to her albinism, fled her native Côte d'Ivoire on August 13, 2012 to Tunisia. She was hoping to find a better life in another African country. Shortly after her arrival in Tunisia she obtained refugee status from the UNHCR. Despite her refugee status in Tunisia, the woman's life has not improved as much as she had hoped, summarizing her experience by saying: "Here, people slap me, insult me and mock me. I don't have a job and I am unable to become integrated". <u>Kenya</u>

13 reports: 5 killings / 8 survivors

Killing	On September 20, 2015, a 56 year old man with albinism by the name of E.J. succumbed to injuries from a brutal machete attack and died. Ten days earlier on September 10, 2015, it was reported that E survived a ritual attack by three men armed with pangas at his home in Gavudunyi village, Hamisi Subcounty, Vihiga county, Kenya. "When I told them I did not have any money, they asked for my ear or hand to sell to Tanzania," he said. A struggle ensued and the attackers sliced his left ear, arm, neck and fingers which left him unconscious. His brother Nickson Lugadiru, also with albinism, said E was found in that state by his son, who called for help.
	L took his brother to Hamisi Subcounty Hospital, where he was referred to Vihiga. E was operated on for three hours after which medics said he was out of danger. The attack has rekindled concerns over the security of people with albinism ahead of Tanzania's October elections. "The attackers wanted my brother's body parts to sell to Tanzania," said Lugadiru who is one of four PWA in their family. The national coordinator of Kenya's Albinism Empowerment Network, Martin Wanyonyi, visited E at the hospital, condemned the attack and said if the criminals are not apprehended within 48 hours, his network would take to the streets in protest.

<u>Survivor</u>	On Friday, March 15, 2013, a 7-year-old boy with albinism in Embu, Kenya, managed to escape relatives who tried to sell him for ritual purposes. AFP reports that according to police, armed men abducted and beheaded the five-year-old girl with albinism in what was feared to be a ritual murder for supposedly magic body parts. Little D "was sleeping in the courtyard with her mother and her sister" when the men snatched her at around 2:00 am on Sunday.
<u>Killing</u>	The girl's mother pursued the kidnappers, who scaled a wall with her child, but then turned back to protect her second daughter, also with albinism. "We searched for the little girl everywhere. We found her body beside a mosque, but she had no head," said a village teacher, Oumar Diakite. Sissoko, the general secretary of the Federation of Associations of Persons with Albinism in West Africa (FAPAO), pointed out the link between crimes against people with albinism and political events, ahead of Mali's presidential election on July 29. "Every time there are elections, we become prey for people who want to make ritual sacrifices. This is not the first time this has happened in Fana," he said. "The state needs to take up its responsibilities." "We demand justice. Her head was taken. This is a ritual crime," activist Mamadou Sissoko told AFP after going to the scene.
	The governor of the region of KOULIKORO , C.M.C., the director general of the national gendarmerie, the Commander of the Legion of gendarmerie were on the crime scene, and went to the morgue to see the body of the beheaded little girl. Traditional authorities have been approached to help appease tensions.



He woke up 2 times in the early morning from being **Survivor** distracted by the uncle. John fell asleep again, but barely 5 minutes into his sleep after 4 am, he felt a sharp pain on his neck and when he woke up, he saw the uncle on him with a knife, he asked him why, but the uncle attempted to stab him twice and strangled him once. In self-defense, John held his uncle's manhood to free himself from strangulation because he was already bleeding profusely from the neck area. After the uncle let go, John screamed for help for about 5 minutes, during which the uncle tried to stab him again, but his neighbors broke the door down and entered the room to rescue him. The uncle was apprehended and taken to the station. When John confronted him, he said he was only "dreaming". John called his mother who told him that an uncle tried to kill her a few weeks ago which he got away with. John has a voice recording of the uncle's friend testifying that if he didn't find money, he would attempt the ritual. Some of the uncle's friends in Owerri said they saw him leave the state around 5 pm on June 24th, 2023, for Anambra State. After the attack, the uncle was held at the army barracks and then taken into custody at Akwuzu SARS station in Anambra State on August 5th, 2023 where he is still held. John spoke to the Investigating Police Officer on August 24th, 2023, and has another appointment on September 5, 2023. John called for justice to be served since it was an attempted murder. They suspect she may also be involved with M's disappearance. His mother is pleased with the latest development in the case saying "I hadn't heard of the arrest from

	police. I've no words to describe how I feel about the arrest but I haven't lost hope and I won't ever lose hope". As of July 27, 2016, police are still busy following leads but little M is still missing. The Albinism Society of South Africa is also monitoring this case and we will keep UTSS informed.

Swaziland (Eswatini)

12 reports: 4 killings / 8 survivors

Killings	In May of 2016, in Nkoyoyo, Swaziland, a man with albinism by the name of S.M. was murdered by his wife, Pinky Z She hired 2 men to kill her husband and then tried to sell his corpse to a traditional healer (name withheld) who allegedly entered into an agreement with her. He is now the subject of intense police investigation. The wife along with the two men have since been arrested and charged for the murder. Prior to their arrest, Pinky took the traditional healer to see the corpse at which time she asked to be paid for keeping her end of the agreement. The traditional healer is said to have backed out of the deal because he wanted M to be brought to him alive since he needed the blood of a person with albinism for ritual purposes. <u>Survivor</u>	On November 25, 2019, a 3-year-old girl with albinism and her mother narrowly escaped a dangerous encounter in the Southern part of the Lubombo region in Eswatini after unknown men arrived at their home demanding the child with albinism. Fortunately, the mother and child were not home at the time.

78 killings; 98 survivors; 1 missing, 26 grave desecrations; 3 asylums

*All Tanzanian information on killings and attacks are gathered by UTSS through its field work and research; reports from victim's families and police reports in Tanzania.

Killing	J.M.M. (49-year-old man): On November 3, 2022 in the region of Mwanza and village of Ngula, J.M. and his friend went out for a drink and later returned home. Upon returning home, he was asked to go out again by this same friend, but his wife advised him not to go as it was getting late in the night. A few hours later, his wife claimed that she heard someone calling her husband's name outside. When she went outside, she heard noises from her husband who said people were chopping off his hand. His right arm was severed below the elbow. // Alternate report: Assailants broke into J's house where he was sleeping with his wife and severed his right arm. J died from the injuries he sustained.// The police are still questioning his wife and looking for a friend of the deceased who was drinking alcohol with him. The regional commissioner of Mwanza, A.M., has given the police force seven days, beginning November 3, to conduct an investigation to identify the killers.



	UPDATES: According to the police, on November 6, 2012, at 12:00 noon, the accused was seen in the village of Ngula, Kanyere Ward in Misungwi district, with a black bag, which the citizens suspected, and they immediately informed the police when they arrived and searched. The bag was discovered to be a rotting human hand emitting a strong odour. Update from UTSS/VoH, Tanzania.
Survivor	Z.E.: On 28th August 2022, in the Shinyanga region of Tanzania, a man on a motorbike went up to Z, a woman with albinism, asking for excrements from her or from a child who has albinism for ritualistic purposes. He promised her that if she gave him this, then a rich person could purchase it for 7 million Tanzanian shillings (approx. \$3000 USD) and that she would get a cut from that amount Z. recorded him with her mobile phone as he departed. She had told the man to come around 2 pm the same day to collect the excrements. At the same time, she informed the police and arranged for them to come to her place to arrest the man who was supposedly going to collect the excrements. They came to her place around 2 pm, the man was caught by police and he admitted that there are others who are doing the same thing in the regions of Shinyanga and Mwanza. The man was detained pending further investigation. On October 20, 2017, a thirty year old woman with
albinism (name withheld) survived an attempted rape by
Bundala Luhende, age 20, at around 11:00 AM at her
parents' house in Mhunze Village, Kishapu District,



Survivor of Rape	 Shinyanga Region, northwestern Tanzania. That day the victim was home alone when the perpetrator, who was unknown to them and not from their neighbourhood, arrived at the door claiming to be hungry and in need of food. When she told him that there was no food in the house he proceeded to offer her money in exchange for sexual favours. She declined and asked him to leave, at which time the man started forcing himself on her. Zainabu began to scream and a neighbour came to her rescue. The criminal escaped but was chased down by villagers, captured and handed over to the police. The perpetrator is now in custody at Kishapu Police Station waiting to be arraigned in court on November 07, 2017. While the victim survived and is safe and in the care of her parents, she is frightened and psychologically affected by the whole ordeal. The UTSS First Response Team has asked the Kishapu District Commissioner to ensure that she gets proper counseling and sent to a Vocational Training Centre where she can do something that would generate income instead of staying at home in isolation. They also asked the Community Development Officer to link her with a women's self-help group. (Trusted Source: Initial report on October 25, 2017, from partners in the Kagera Region and the Tanzania Albinism Society (TAS) in Simiyu. <u>Missing</u>	 Tanzania. The police have arrested 15 suspects in connection with the kidnapping. Three of the arrestees are relatives: P's paternal grandfather, maternal grandfather and her mother. Due to the fact that her mother had just given birth to a baby girl with albinism and prison would not be appropriate for the baby, the Mwanza Regional Commissioner has ordered them to be sent to an alternative secured environment. The police have also set up a search party to look for P. (Trusted Source: UTSS interview with Tanzanian police and Ndamhi Village Executive Officer, <i>MWANZA</i>, <i>TANZANIA – four year old girl with albinism kidnapped; December 27, 2014.</i>)
<u>Grave</u> Desecration	On October 26, 2021, the grave H.K. in the region of Tanga, was desecrated and his entire remains plus coffin taken and has not been found. H passed away around spring last year from skin cancer (age: 40 estimation) (Trusted Source: To protect our sources, we have withheld their names from this publication, <i>TANGA, TANZANIA – man's grave desecrated and remains taken; October 26, 2021.</i>)
	On July 28, 2017, a man with albinism from Tanzania was granted refugee status in Vancouver, Canada.

Togo

1 report: 1 killing

Killing	On September 23, 2017, a 2 year old boy with albinism by the name of N.M. was reported missing between 8:00 and 9:00 PM in the city of Dapaong in the locality of Pana Bagou in northern Togo, West Africa. The little boy was later found dead and 62nclud. It was reported that the victim's body was supposed to be exhumed on the third day following his burial and taken to the neighboring country of Benin to serve in witchcraft practices for the purpose of bringing riches. Some of the 4 suspected murderers have been arrested and are currently in the hands of the local police. The Togo Albinism Association ANAT says "We have a video footage of the burial of the little boy. We firmly condemn this act and demand your support to say NO to these acts in our country." <u>Uganda</u>

9 reports: 8 survivors / 1 asylum

<u>Asylum</u>	Legal history was made in the USA when, on December 16, 2020, a 34-year-old woman with albinism from Uganda was granted asylum in Boston, Massachusetts.
Survivor	This report counts as 2 separate PWA attacks – On October 7, 2016, 2 boys with albinism were kidnapped in the village of Bujuko in Central Uganda. They are part of a family with many children among whom four have albinism. The mother is facing many challenges after separating from her husband who wanted to sacrifice one of the children with albinism. The kidnapping occurred while four of the siblings were on their way to school and the two older boys were blindfolded with handkerchiefs believed to have chemicals on them. Some people saw the boys in a taxi and telephoned their mother asking if she knew where the boys were going. Oblivious of the situation, she denied that they were her children but the other person insisted on their identity. A one and a half day search began for the boys who were miraculously found alive and well in a medium income Kampala suburb looking for their way home. It was a long search using police, local radio stations and word of mouth. The case is still under investigation and a lot of information is not yet available. (Trusted Source: To protect our sources, we have withheld their names from this publication – BUJUKO, UGANDA – two boys with albinism survive kidnapping; October 17, 2016.)



2 reports: 2 survivors

	This report counts as 21 PWA attacks – In 1899, at the turn of the 20 th century, two young African-American brothers with albinism by the names of G. (6) and W. (9) M. went missing in the Jim Crow South Town of Truevine, Virginia, USA. G and W were two little boys born to a sharecropper family on a sweltering tobacco farm. One day a white man by the name of James "Candy" Shelton offered them a piece of candy, setting off events that would traffic them around the world and change their lives forever.
Survivors	From the time these two vulnerable boys were kidnapped, they were lied to by their Circus management captors and told that their mother was dead. As far as G and W were concerned, they were now totally on their own for the rest of their lives. Captured into the circus, the M brothers performed for royalty at Buckingham Palace and headlined over a dozen sold-out shows at New York's Madison Square Garden. They were global "superstars" in a pre-broadcast era. But the very root of their "success" was in the color of their skin and in the outrageous caricatures they were forced to assume: supposed cannibals, sheep-headed freaks, even "Ambassadors from Mars." The M brothers were victims of violence, for what else is peonage but violence? Back home, their mother H.M. never accepted that they were "gone" and spent at least 13 years trying to get them back, never stopping the searching for her sons. H placed missing-persons notices in Billboard and eventually found her sons. She helped them seize control over their lives, discovering that they were illiterate having never received an education. G and W returned to the circus in 1928 as paid employees. Love and kinship impelled H's family to try



for a century to protect G and W from a world that saw them as objects for exploitation. The family always believed the boys were kidnapped, including W's personal testimony as an adult. G died in 1972, and W in 2001, at 108. W did not die a bitter man. He repeated the words "God has been good to me" so many times that it is now etched on his tombstone in Truevine, Virginia.




28 reports: 10 killings / 12 survivors / 4 grave desecrations

Killing	(47-year-old man): On July 18, 2023, at around 9 am, Mr. C.B., aged 47 years old, was at Mr. T.P's house (his brother in-law) in the village of Nkungulu in the District of Katete (Eastern Province). Later on, Mr. K.P.B. came by the house to pick up Mr. C to give him some sweet potatoes that he had promised him. That was the last time he was seen. On July 22, 2023, the Katete Police Station received information that someone was in possession of the human body parts of a person with albinism and that the seller was in a town called Chadiza at the Chanida border in the Eastern Province. A follow-up was made by a combined team of Police Officers from Katete and Chadiza whereby one of the police officers posed as an interested buyer. Mr. P.B. aged 20 years old, from the village of Chongololo in the District of Katete was approached by the buyers and from his bag, he produced what was suspected to be human hair. He later took the "buyer" to where the body was located along the Musadwe stream near Nkungulu village in the District of S51,479 USD). The body was later retrieved by a team of police officers and upon physical inspection, the deceased's neck was bruised and swollen, and part of the head was shaved. The victim was identified as Mr. C.B. His relatives, who were not aware of the incident, were later informed. K.P.B was detained and taken into police custody.

<u>Survivor</u>	(16-year-old boy): On June 3, 2023, 4 men (two of whom are the same men who attempted to traffic the 41 year old man with albinism below) attempted to traffic a 16-year old boy with albinism between 16:00 and 18:00 hours in Mawire compound in Kalomo District of Southern Province. The boy is a Grade 10 student at Kalomo Secondary School. The five accused persons are all in custody and will appear in court soon in Kalomo District. Police have charged and arrested the two additional suspects for two counts of human trafficking. The other two were already charged with the attempted kidnapping of the 41-year-old man with albinism. A total of 5 suspects were charged and arrested.
	(41-year-old man): On June 3, 2023 , three men, attempted to traffic a 41 year old man from Mwandi District for the price of 500,000 ZMK (\$25 USD) at a guest house in Kalomo District (Southern Province). All three suspects have been charged and arrested with two counts of human trafficking.

<u>Grave</u> Desecration	 (1) WHAT HAPPENED? The body of a male juvenile Widson Mkandawire aged 14 years a boy with albinism who died and was buried on the 18th of January 2022 was exhumed/unearthed by unknown people. (2) WHERE2 In Mundalanda village. Chief K. Chama
	(2) WHERE? In Mundalanga village, Chief K, Chama district of the now Eastern province of Zambia.

	(3) WHEN? At unknown time on the 27th of January 2022.
	(4) CURRENT SITUATION? The body was inspected by Chama police officers and we ascertain that the left hand of the deceased person with albinism was missing/ chopped off by unknown people. The relatives were advised to re-bury the grave and put a tombstone to avoid reoccurrence because it's believed that they use such parts for rituals.
	(5) CONSENT OF VICTIM? The mother to the buried deceased F/ G.K. aged 37 years of Mungwalala village chief Kambombo Chama district was consulted and she gave us a go ahead.
	(6) INFORMATION ON THE PERPETRATORS? Currently we have no information about who could have done this barbaric act. However, it's under investigation by Chama police station.
	(7) ACTION TAKEN BY THE STATE? An investigation has been instituted by the state and a docket of case has since been opened.
	(8) ACTION TAKEN BY VICTIM? The family of the deceased person with albinism in collaboration with the community at large were advised to remain patient and assist the police with any information which will lead to the apprehension/arrests of the perpetrator. The grave was re-buried and a tombstone put in place. This is after they reported the matter to chama police station and scene visit conducted.

2 reports: 1 killing / 1 asylum

<u>Killing</u>	In 2011 the severely mutilated body of a 26 year old woman with albinism was discovered. Professor J.M. was contacted by Zimbabwe police and taken to the morgue to assist in identifying the body. He noted that she had albinism and that her breasts and genitals had been removed. (Trusted Source: To protect our sources, we have withheld their names from this publication, <i>ZIMBABWE – twenty six year old woman with albinism killed discovered; 2011.</i>)
<u>Asylum</u>	On November 29, 2012 , a woman with albinism from Zimbabwe was granted asylum in Atlanta, Georgia. (Trusted Source: To protect our sources, we have withheld their names form this publication.)



NOTE 1: Many attacks & killings of PWA in Africa are not documented or reported. UTSS is certain that crimes of colour against PWA are common in various parts of almost all African countries. LEGENDS & MYTHS ABOUND, AND UTSS HAS YET TO HEAR OF ONE THAT IS HUMANIZING.

Most myths reduce PWA to ghosts, magical beings or curses, etc. On rare occasion the discrimination is reversed and the PWA are "deified" into "gods". Either way, they rarely get to enjoy their status as normal human beings. Many countries have stories about the mysterious disappearance of PWA. There is a growing, documented truth to these rumors. We know that many PWA have "disappeared" due to abduction, then mutilated and killed by fellow citizens (sometimes family members "friends" or neighbors) for the purpose of witchcraft related rituals.

These ritual attacks frequently find their roots in ancient ancestral beliefs, are a familiar concept to most Africans, and have been going on since time beyond memory.

NOTE 2: Countries known to be involved in the cross-border trade of PWA and their body parts: Tanzania, Burundi, Kenya, DRC, Mozambique, Malawi, South Africa, Swaziland.
