# Benin

18 reports: 5 killings / 5 survivors / 7 missing / 1 exhumation

| <p><b><u>Survivor</u></b></p> | <p><b>On August 4, 2017, a 13-year-old girl with albinism</b> (<i>name withheld</i>) narrowly escaped abduction and was found unharmed the following day in Dogbo in the southwest of Benin. According to the victim's cousin, V.G., she was just leaving the marketplace with one of her sisters and was in the neighborhood of Dogbo Zaphi public primary school when the kidnappers approached frightening the victim's sister away and abducting her in a black Ford Focus with the license number AY 4078. The police were immediately alerted and launched a large patrol of the surrounding area.</p> <p>Under intense pressure, the kidnappers were forced to release the victim in a bush where she spent the night. The following morning, she found help and was reunited with her family at the Dogbo's Police station with the General Director of the National Police. All 3 suspects who committed the abduction are Beninese from Dogbo and have been arrested by Commander CIE APLAHOUE and his team and will be presented to a public prosecutor.</p> |
|                               | <p><b>On July 13, 2013, a 20-year-old man with albinism</b> known as F.M.H. was deceived, drugged, kidnapped, killed, and mutilated in his homeland of Benin. F.M.H lived in the community of Lalo in south-western Benin, where he was learning to become a nurse in one of the hospitals at Lalo Centre. F.H. had a cousin</p>  |

named P.H. who lived in Koudjon Centre, a small village near Lalo. Both boys had grown up together in the same hamlet of Ouinsouhoué.

On that fateful day, P.H. approached his cousin with albinism in order to deceive him, saying that he'd found a high paying job for him in downtown Cotonou, and that the boss wanted to meet right away. F.H. showed no hesitation and after a 3 hour ride, they went to wait for the so-called boss in a bar. Here F.H. was drugged and kidnapped to Porto-Novo, the country's capital city, where he was killed, and parts of his body removed. When P.H returned home to Lalo alone, everyone started asking for F.H. P.H. kept insisting that he had not traveled anywhere with F.H. Since many had seen them travelling together, people started threatening him to tell the truth. To conceal the truth and silence the family, he decided to consult various witchdoctors to make him amulets.

Finally, he and his three accomplices went to consult one of the visionaries of the Celestial Churches of Christ. He told him the whole story and begged him to mystically silence everyone about the murder in exchange for a lot of money. The visionary left his house briefly and called the police, who arrived quickly. The criminals tried to escape but the police shot one of them and all four were arrested and placed in custody. Of the four, one was released when it was discovered that he was the younger brother of one of the criminals and had nothing to do with the murder. The other three were placed in the prison in Lokossa and are serving their sentences.



**Missing**

**On March 23, 2019, a 45-year-old man with albinism** by the name of A.A. went missing in the city of Abomey, Zou Department, Benin. The victim was a well-known joiner (carpenter) who lived in the A.A.’s home and had his joinery business opposite the D.T. Much to the dismay of his family, the victim’s younger brother may have been involved in his disappearance. According to a cousin, A.A. had some work to do for an old man who had called him in the morning of Saturday, March 23, indicating that the door locks had been purchased and that he should come to make the repairs. A.A. has not been heard from since. The old man was questioned over the disappearance but denies that A.A. met with him that day. F.H., founder and chairperson of Beninese Albinism NGO has raised the alert, asking anyone who has any suspicions about A.A.’s destination that day to inform the police or the nearest local authority. He concluded by saying: “I pray we find A unharmed for the sake of his family and the nation. I appeal parents to look after their children with albinism. I also warn adults with albinism against going unaccompanied to a meeting even if they know the person who invites them to that meeting.”

**In September of 2018, a 50-year-old woman with albinism** by the name of D.C.K. ends up dying of skin cancer after which her lifeless body was decapitated by a family member at her burial in the woods near her family home in the community of Allada, Atlantique Department, Benin. Over the span of multiple unknown dates throughout the course of her life, the deceased had survived numerous abductions attempts and other inhumane cruelties at the hands of her family. D.C.K. had always been disowned by her father’s family who compared her

to a white monster along with many other punishing psychological abuses. She never did manage to move past these cruelties and build a family of her own. At one-point she was very sick with wounds all over her body and finally decided to seek assistance from her mother's younger sister, hoping for a more supportive response.

Tragically, and to her great surprise, she was ill-treated by her aunt as well, being forced to cook despite her poor vision and deteriorating health. One day while cooking, a fire broke out in the kitchen due to her only having sight in one eye which she suffered from low vision; she didn't immediately notice the fire and was nearly burnt alive. Thankfully, she was rescued by some neighbors. To make life worse, her aunt colluded with a witch doctor to get rid of her for good. The aunt told D.C.K. that she knew of a witch doctor who could heal her but that the treatment consisted of pouring boiling water over the left side of her face. This was pure torture for the victim who screamed for help while being overpowered by the perpetrators. She lost half of her left ear during this so-called "cure" ritual, and the skin on her face had all but disappeared and became infested with maggots. Upon arrival at hospital, the doctors denounced the so-called treatment, describing it as Machiavellian. In September of 2018, D.C.K. died of skin cancer.

Her body was immediately apprehended by the family who refused to give her a decent funeral, saying that she did not deserve a coffin or a grave in a cemetery. One of the C.K. family members publicly declared that he needed her head because, since childhood, she had been very lucky, having escaped their many attempted kidnappings. N.K., one of the deceased cousins, insisted on participating in the burial in the bush in

|  | <p>ALLADA. Following the funeral, N.K. told the police that the body's head had been removed before it was buried. The police warned him against pushing the case further for fear that he may be killed by the family. They went on to tell N.K. that this was a family matter and that there was no need to "make noise" about the body parts that had been removed since the victim was already dead.</p> |

| <p><b><u>Survivor</u></b></p> | <p><b>In September of 1998, a 27-year-old woman with albinism</b> (name withheld) narrowly escaped a second plot against her life. The incident took place at Kanye, her native village in Southern Botswana. Although the victim was a primary school teacher in the city of Jwaneng, Botswana, she was pregnant and staying in her native village at the time. On this near fateful day, her young brother encountered three guys in the village night club who knew S.</p> <p>They offered him some beer to get him drunk, hoping to manipulate him into joining their murder plot against his sister. Fortunately, he sensed something was wrong and secretly managed to replace the beer with water while pretending to be drunk. The guys asked him: “Where is your sister, the albino teacher?” “Your sister could actually make the deal: She is albino and pregnant!” “We want her flesh...!”. The victim’s brother lied, telling them she was teaching in Jwanenge city but would be home for the weekend and that they could find her then. When he got home from the club that evening, the victim’s brother told her everything and warned her to leave immediately to Jwanenge city for her safety. After that incident, S stayed in the city for a long time.</p> |

He said the men had come from Tanzania and were headed to Ouagadougou, in Burkina Faso and that they used loud, offensive language as the airline attendant asked for the missing passport – they had three passports and none for the child. | <p><b><u>Killing</u></b></p>  | <p><b>On February 1, 2022</b>, it was reported that the dismembered remains of a 4-year-old boy with albinism were found.</p> <p>It was also reported that three people drove up in a car and abducted the boy off the street on the Saturday as he was playing with other children on the outskirts of Burundi’s biggest city Bujumbura.</p> <p>The kidnappers drove the victim, whose name was given as A., somewhere 230 (145 miles) kilometres to Cankuzo province where he was killed and dismembered, said the albinism organization, ASF, and a local administrative official.</p> <p>“A was killed, then his executioners cut off his arms and legs before removing the bones and sharing them around. | <p><b><u>Killing</u></b></p>    | <p><b>On Sunday, August 29, 2021</b>, after multiple searches had yielded no results, F.F.'s mutilated remains were discovered in Bafoussam in the West region with several of the victim's organs missing. According to the newspaper Nouvelle Expression, the victim is a man in his forties, a trader at the A market in Bafoussam. Police officers from the Bafoussam 1st Police Station indicate the body was amputated and organs taken by the alleged murderers. The chief warrant officer, deputy commander of the Djeleng 5 gendarmerie brigade, quoted by the newspaper, indicates that more in-depth research is underway. This will allow the investigation into this atrocious assassination to progress as quickly as possible.</p> |
| <p><b><u>Survivor</u></b></p>   | <p><b>In 2013, a mother and her infant with albinism</b> began the process of seeking asylum in France as she feared for the life of her child in Cameroon, where members of her community attempted to kill the baby for ritual purposes during local elections.</p>   |
| <p><b><u>Asylum</u></b></p>     | <p><b>On December 23, 2015, a man with albinism</b> (name withheld) from Cameroon was granted refugee status in UK.<br/>(Trusted Source: Interviews with UTSS)</p>  |
| <p><b><u>Exhumation</u></b></p> | <p><b>In 1999, the body of a girl with albinism</b> by the name B.M. (25) was stolen from the Morgue of the Hospital Jamot in Yaounde, Cameroon. According to a report from B.M.'s family, a local gang committed the gruesome act of stealing her body during the night, removing her fingernails, pubic hair, and hair. It was during the girl's funeral that her family noticed the saddening mutilation</p>   |

J.K. was killed when he was kidnapped from his family’s home by thugs who could be identified. The thugs locked the child’s family in their house when they kidnapped and murdered the little boy. | <p><b><u>Exhumation</u></b></p> | <p><b>On March 16, 2021, there was an attempt to exhume</b> the grave of a woman with albinism, C.N.F., who had died at the age of 74 in Lubunga, DR Congo. The case was reported by an NGO in DRC to the Africa Albinism Network.</p> <p><b>In the early hours of March 25, 2019</b>, the grave of a man with albinism by the name of G., who had died a month and a half earlier, was vandalized at his family plot in the ward of CIRIRI, in the community of BAGIRA, BUKAVU District, SOUTH KIVU Province, DRC. The remains of the deceased were exhumed, dismembered and body parts stolen. A local resident by the name of R.C. said it's not the first time that the grave of a PWA has been tampered with, and body parts taken in the area of BUKAVU. It is alleged that these acts are committed for witchcraft purposes. ### Asylum

**On Friday, September 16, 2011**, (name withheld), a 28-year-old man with albinism from Egypt, told journalist S.B. about his life in Egypt and his newfound asylum in New Zealand. He contrasted the profound discrimination facing people with albinism in Egypt with the amazing and equal opportunities he has found in New Zealand. The man’s lawyer said: “He was seriously maltreated at multiple levels including such things as deliberate cigarette burns from supposed educators... The hostility toward him was serious at best because of his Albinism. He has now been able to both marry and continue his studies. He is one of the nicest and most considerate people I have met in a long time and doing very well.” The man says; “I want to be a professor in the university. The first time I ever got a salary was here in New Zealand. I can support myself and my research. I don’t want to go back to Egypt, not even for a visit.”

| <p><b><u>Killing</u></b></p>  | <p><b>On February 17, 2015, the lifeless body of a 35 year old man with albinism by the name of K.Y. aka A. was found at the entrance of Pastor E.A.'s residence in Owoakra, Boketey, under Amanase in the eastern region of Ghana. According to the pastor's wife, G.A., her husband ran off shortly after the death of K.Y. and she has not heard from him since. Unfortunately, the police have not been responsive to crimes committed in this area and allowed Pastor E.A. to escape without questioning. Since that time however, police commander S.P.T.Y. of Suhum police station announced that because of the public interest whipped up by media related to the death of K.Y., the homicide unit at police headquarters in Accra had taken over the investigation.</b></p>   |
| <p><b><u>Survivor</u></b></p> | <p><b>On January 1, 2023, a 16-year-old boy with albinism from the town of Garu in the Upper East region of North Ghana was playing football with his teammates while celebrating the new year when the perpetrator approached him on a motorbike. The perpetrator pleaded with the victim to go with him to get his bicycle from a nearby neighborhood and bring it back to where they were playing football since he couldn't ride two bikes at once. The survivor consented, but when they reached the said neighborhood, the perpetrator didn't stop. When the survivor protested, he insisted he stops at the next neighborhood. Upon reaching the next neighborhood, the perpetrator still refused to stop despite the survivor's protests, so he jumped off the bike, and in an attempt to flee, he met a lady and narrated the story. Little did he know, she was the main perpetrator and had a syndicate following them on a motorcycle. Upon arriving, he verified their participation in the attempted abduction.</b></p> |

| <p><b><u>Killing</u></b></p>  | <p><b>On a Sunday in September of 2010</b>, at the area of <i>La Carrière</i>, in the town of Matam, district of Conakry, the body of a PWA was found with the eyes missing— very likely removed with a knife. According to our source, the unnamed PWA used to wander daily in that area with some friends, looking for their daily bread. The victim’s life is made up of begging at the big market of Matam’s main station and on the streets of the Capital City. One morning his lifeless body was found laying on the sidewalk.</p>   |
| <p><b><u>Survivor</u></b></p> | <p><b>On May 17, 2017 a four-year-old girl with albinism</b> (name withheld) narrowly escaped a ritual tragedy after being rescued from 4 men who had abducted the victim in the country village of Damankania, in the Sinanya district of Yabara, Guinea. The suspected traffickers kidnapped the little girl in front of her mother at their home. Her father S.C. explains: “a young man got out of a vehicle that was parked in front of my compound and snatched our daughter. My wife who was on the scene asked the kidnappers where they were taking her. Without answering they drove off with the little child. My wife shouted for a motorbike taxi to chase the kidnappers. I immediately alerted the Commander of the Gendarmerie (police) who deployed his team and managed to capture the vehicle. Of the 4 assailants, 2 succeeded in escaping and the other two were arrested.” Accused of</p> |

| <p><b><u>Killing</u></b></p> | <p><b>A person with albinism buried on March 7th, 2024, at 3 AM along the Côte d'Ivoire and Burkina Faso border.</b> The PWA was kidnapped at the CIV/Ghana border between the town of Tanda in CIV and the town of Gunasua in Ghana and sacrificed to allegedly meet the political agenda of Senior members of the Ivoirian political leadership to sow discord between Burkinabe President I.T. and his Intelligence Chief O.Y. and ultimately overthrow the current Burkinabe leadership. In a meeting, a member of the Ivoirian senior leadership was allegedly heard to have said that he believed in witchcraft and found a powerful and dangerous witchdoctor in the region of Siguiri in Guinea who said he could sow discord and divide I.T. and O.Y. They brought the witchdoctor to Abidjan. After spending 1 week in retreat in a cemetery in Abidjan, the witchdoctor asked for a person with albinism (PWA) to sacrifice. He said that once they decapitated the PWA, their tongue and genital organs will be buried along the border of Côte d'Ivoire and Burkina Faso (CIV/BF) border and the blood collected while the PWA is immolated has to be spilled on Burkinabe territory which will increase the rise of power and influence of terrorist groups on Burkinabe territory. Then the return of violence on Burkinabe territory will cause citizens to be unhappy and turn against I.T. and his leadership and overthrow them. The burial of the PWA's organs will cause the immediate division between I.T. and O.Y. The witchdoctor estimated that there will be serious divisions between the two men in the coming 3- 8 months and that they will hate each other. They recruited a woman who is renowned and who specializes in organ trafficking to kidnap the PWA. She is from a neighboring country to CIV and is close to members of the Ivoirian Senior leadership. **29-year-old woman with albinism** (name withheld) whom is also a mother of a 13-year-old daughter and an 8-year-old son who, just four days after narrowly escaping a second attack due to her albinism, fled her native Côte d'Ivoire on August 13, 2012, to Tunisia. She was hoping to find a better life in another African country. Shortly after her arrival in Tunisia, she obtained refugee status from the UNHCR. Despite her refugee status in Tunisia, the woman's life has not improved as much as she had hoped, summarizing her experience by saying: "Here, people slap me, insult me, and mock me. I don't have a job, and I am unable to become integrated".

## Killing

**On September 20, 2015, a 56-year-old man with albinism** by the name of E.J. succumbed to injuries from a brutal machete attack and died. Ten days earlier, on September 10, 2015, it was reported that E.J. survived a ritual attack by three men armed with pangas at his home in Gavudunyi village, Hamisi Subcounty, Vihiga County, Kenya. “When I told them I did not have any money, they asked for my ear or hand to sell to Tanzania,” he said. A struggle ensued, and the attackers sliced his left ear, arm, neck, and fingers, which left him unconscious. His brother N.L., also with albinism, said E.J. was found in that state by his son, who called for help.

N.L. took his brother to Hamisi Subcounty Hospital, where he was referred to Vihiga. E.J. was operated on for three hours after which medics said he was out of danger. The attack has rekindled concerns over the security of people with albinism ahead of Tanzania’s October elections. “The attackers wanted my brother’s body parts to sell to Tanzania,” said N.L. who is one of four PWAs in their family. The national coordinator of Kenya’s Albinism Empowerment Network, M.W., visited E.J. at the hospital, condemned the attack, and said if the criminals are not apprehended within 48 hours, his network would take to the streets in protest.

According to a police spokesperson, Senior Inspector C.M., a woman from the victim’s district arrested in connection with the murder was assisting with investigations. T.T met the suspect at an initiation school where they were both initiates.

He declined to disclose more details, saying it would compromise investigations. He went on to say, “We are not in a position to disclose whether the crime was committed as a result of superstitious beliefs or not. All I can say is investigations are ongoing. Once the investigations have been completed, the case will be brought before the court, and the offenders will face the wrath of the law.”

**(6-year-old boy) On the night of 25 October 2025**, a woman was fast asleep with her 6-year-old son with albinism in her house. It was just the two of them in the house when, at around 2 am, she woke up to the sound of glass shattering in her bedroom. Upon inspection, she discovered that four people, some of whom had also smashed her living room windows, were actively trying to break into her house. The perpetrators did not stop doing that until she screamed only then her neighbours woke up to check what was going on, and they run away. Aside from her and the neighbours' vigilance, the fact that her house is secured with iron bars on the windows were also the reason why the perpetrators were unable to break into the house. She was advised by the APAM Chiradzulu Chapter Chair, whom she had called immediately after, to report the incident to the Police. As it was a Saturday, she was able to physically go to the nearest station to report the incident in the morning. The Police from Chimowa Station then came on the same day to collect witness statements, thus starting their investigation. Two days later, on 27 October, the Police Commissioner from Lutchenza Regional Station came to conduct further investigations. The next day, Mr. B.M. (the Chiradzulu APAM Chapter Chairperson) was visited by CID (Criminal Investigation Department) officials, who further interviewed him regarding what he knew about the incident. No one heard from the Police after this, until some days, when they conducted an albinism awareness event in the same community. It is worth noting that immediately after this incident, the woman and her son left their house and stayed with relatives, as they felt unsafe to continue staying there. After the awareness event that happened in early November, no updates were provided by the Police despite Mr. B.M.'s inquiries. When he expressed dissatisfaction with how the process was going and fear that the child might still be a target, the Police then proposed moving the child to an orphanage called The Good Samaritan, to at least ease the security concerns as the investigation continued. **I.M.: On 17 November 2025,** A man with albinism had been drinking with his friends at a Joint near his house. Eyewitnesses say he departed from the joint at around 2 PM and headed towards Gomiwa, which is a neighbouring village. When he came back, he was seen walking back to the joint with strangers. In fact, his fellow village man, who had also gone to the same joint at around 7 pm, saw him still drinking and interacting with them. He was uncomfortable with these strangers and had to return there three more times just to confirm that they had departed. Also present at the joint around that time was K., who, just the previous day, had nearly fought with I.M. Those familiar with the two describe their history as being rather adversarial, and on the previous day, this had manifested into a volatile situation where taunts and insults were exchanged. This was the last time anyone would see I.M., who, up to now, remains missing. Even though the matter was reported to the Police at Mulanje Station, there was no immediate feedback on the progress of the investigations.

13 December 2025, 3 weeks after I.M.'s disappearance, B.M., together with officials from Standing Voice, made follow-ups with the Police in Mulanje. They were told that the matter is still under investigation, that there was no new information, and that they were "working together with our colleagues from Lutchenza Regional Station". No arrests made, no interrogations made since the report was made three weeks earlier, no current information whatsoever. It was on 12 December 2025 that B.M. got a phone call from Mulanje Police, asking her for the names of the suspects that were submitted to the police as the case was being reported (since she was also present during the reporting). The police were asking because Officials from the Regional Police Station would visit them on the next day, 13th December, and they wanted to follow up to have a response when the officials asked about the matter.

**On May 13, 2018, a five-year-old girl with albinism** by the name of D.D. was kidnapped from her home in the middle of the night and later found beheaded in the village of Fana, about 125 Km from Bamako, the capital of Mali. AFP reports that according to police, armed men abducted and beheaded the five-year-old girl with albinism in what was feared to be a ritual murder for supposedly magic body parts. D.D “was sleeping in the courtyard with her mother and her sister” when the men snatched her at around 2:00 am on Sunday.

The girl’s mother pursued the kidnappers, who scaled a wall with her child, but then turned back to protect her second daughter, also with albinism. “We searched for the little girl everywhere. We found her body beside a mosque, but she had no head,” said a village teacher, Oumar Diakite Sissoko, the general secretary of the Federation of Associations of Persons with Albinism in West Africa (FAPAO), pointed out the link between crimes against people with albinism and political events, ahead of Mali’s presidential election on July 29. “Every time there are elections, we become prey for people who want to make ritual sacrifices. “This is not the first time this has happened in Fana,” he said. “The state needs to take up its responsibilities.” “We demand justice. Her head was taken. This is a ritual crime,” activist Mamadou Sissoko told AFP after going to the scene.

The governor of the region of **KOULIKORO**, C.M.C., the director general of the national gendarmerie, the Commander of the Legion of gendarmerie were on the crime scene and went to the morgue to see the body of the beheaded little girl. Traditional authorities have been approached to help appease tensions.

P.N. has a voice recording of S.D.’s friend testifying that if S.D. didn’t find money, he would attempt the ritual. Some of S.D.’s friends in Owerri said they saw him leave the state around 5 pm on June 24th, 2023, for Anambra State. After the attack, S.D. was held at the army barracks and then taken into custody at Akwuzu SARS station in Anambra State on August 5th, 2023, where he is still held. P.N. spoke to the Investigating Police Officer on August 24th, 2023 and has another appointment on September 5, 2023. P.N. called for justice to be served since it was an attempted murder. ### Killing

**On January 28, 2018, a 14-year-old girl** with albinism by the name of G.S.S. was abducted and later killed in Hlalanikahle Township -Witbank Mpumalanga, South Africa. The family woke up to the sound of commotion made by three men breaking a window and entering at gun point to abduct G.S.S.

They also took her 15-month-old nephew, N.N., who did not have albinism but was allegedly mistaken for another child from the same household who also has albinism.

G.S.S's young body was found 3 weeks later on February 21<sup>st</sup>, 2018. The remains indicated that she had been decapitated, with her arms and private parts removed. The shallow grave was discovered in Cullinan Pretoria which is about 81 km away from her home.

The infant was discovered on the N4 highway with the exact location not disclosed. On February 20, 2018, Thokozani Msibi (32), a traditional healer from Swaziland living in South Africa, was arrested after police found a human head and other human body parts at his home. He confessed to the brutal killing of the two children and identified the location of the shallow grave. He appeared in Witbank Magistrate's Court at which time he was also applying for bail, which M.D.V. denied.

The first court appearance was on February 21, 2018, where he was remanded in custody with the second court appearance on February 27, 2018. The next court date was on March 6, 2018, with investigations still ongoing since the other two suspects have not been apprehended.

## Killing

**On May 30, 2024, a 2-year-old girl** with albinism by the name of A.N. in the Village of Bulamula, Mbale Hamlet, Kamachumu Ward and Division in Muleba District, Kagera Region, was abducted by two young men who strangled A.N's mother who goes by K.R. The family's neighbor, H.R., told the newspaper Sauti Kubwa on May 31, 2024, that the two young men arrived at K.R.'s home, knocked on the door, and asked for salt. They claimed that one of them had been bitten by a snake and needed the salt for emergency treatment. K.R., who was at home with her child at the time, opened the door and gave them the salt while holding her phone's flashlight. However, when she handed them the salt, one of the men grabbed K.R. by the neck while the other quickly entered the house and took the child A.N who was playing in the living room, then fled with the child to an unknown location. H.R. narrated that the young man who strangled the child's mother released her after seeing his accomplice had taken A.N outside, and ran away, leaving the mother crying out for help from the neighbors. After the neighbors heard the cries and gathered at K.R.'s home, they called the police; and the police quickly arrived, conducted interviews, and began an investigation. Approximately 18 days after the incident, on June 17, 2024, the child's body was reported to have been found with its hands, tongue, and eyes cut off. According to a report from the District Executive Director of Muleba, Mr. B.M., the body was discovered abandoned in a water-filled culvert on Makongora Road in Malele Village. On June 19, 2024, the police apprehended nine suspects, including the child's father and a priest from the local church, who were found with a plastic bag containing the missing body parts of the two-year-old, attempting to find a buyer. Oblivious of the situation, she denied that they were her children, but the other person insisted on their identity. A one-and-a-half-day search began for the boys who were miraculously found alive and well in a medium-income Kampala suburb, looking for their way home. It was a long search using police, local radio stations, and word of mouth. ### Survivors

**This report counts as 2 I PWA attacks** – In 1899, at the turn of the 20<sup>th</sup> century, two young African American brothers with albinism by the names of G. (6) and W. (9) M. went missing in the Jim Crow South Town of Truevine, Virginia, USA. G and W were two little boys born to a sharecropper family on a sweltering tobacco farm. One day a white man by the name of James “Candy” Shelton offered them a piece of candy, setting off events that would traffic them around the world and change their lives forever.

From the time these two vulnerable boys were kidnapped, they were lied to by their Circus management captors and told that their mother was dead. As far as G and W were concerned, they were now totally on their own for the rest of their lives. Captured into the circus, the M brothers performed for royalty at Buckingham Palace and headlined over a dozen sold-out shows at New York’s Madison Square Garden. They were global “superstars” in a pre-broadcast era. But the very root of their “success” was in the color of their skin and in the outrageous caricatures they were forced to assume: supposed cannibals, sheep-headed freaks, even “Ambassadors from Mars.” The M brothers were victims of violence, for what else is peonage but violence? Back home, their mother H.M. never accepted that they were “gone” and spent at least 13 years trying to get them back, never stopping the searching for her sons. H placed missing-persons notices in Billboard and eventually found her sons. She helped them seize control over their lives, discovering that they were illiterate, having never received an education. G and W returned to the circus in 1928 as paid employees. Love and kinship impelled H’s family to try for a century to protect G and W from a world that saw them as objects for exploitation. The family always believed the boys were kidnapped, including W’s personal testimony as an adult. G died

in 1972, and W in 2001, at 108. W did not die a bitter man. He repeated the words “God has been good to me” so many times that it is now etched on his tombstone in Truevine, Virginia.

# Zambia

38 reports: 11 killings / 20 survivors / 7 exhumations

## Killing

**M.S. (25-year-old man):** On Friday, February 22, 2025, around 17:00 hours, M.S. was requested by his friends, identified as W.S., C.N, and M.S, to escort them to a nearby village. Tragically, he never returned, and his family grew suspicious after he failed to return home in Lyuchi Village in Chief Waitwika's area in Nakonde District.

A search party was launched, and his body was discovered in a shallow grave on Monday, February 24, 2025, around 06:00 hours, about 150 meters from the Great North Road. Zambia police service Spokesperson R.H. confirmed the development to Chete FM News on Tuesday afternoon. The body was found with gruesome mutilations, including amputated hands, a suspected broken neck, and severe facial disfigurement. Four of his upper front teeth, specifically his incisors, had been removed.

The hoe suspected to have been used to dig the grave was also recovered at the scene. The suspects, an unnamed witch doctor, E.S., W.S., C.N., and M.S., are currently on the run. Police are urging members of the public with any information regarding the whereabouts of the suspects to come forward and assist in the investigation.

Her boyfriend lured her into a marriage proposal. The seven suspects were caught attempting to sell her for 100 million ZMW (Approx. \$38,000 USD). The police were able to intervene before the exchange could take place and apprehended the perpetrators. ## **NOTES**

NOTE 1: Many attacks & killings of PWA in Africa are not documented or reported. UTSS is certain that crimes of colour against PWA are common in various parts of almost all African countries. LEGENDS & MYTHS ABOUND, AND UTSS HAS YET TO HEAR OF ONE THAT IS HUMANIZING.

Most myths reduce PWA to ghosts, magical beings or curses, etc. On rare occasion the discrimination is reversed and the PWA are “deified” into “gods”. Either way, they rarely get to enjoy their status as normal human beings. Many countries have stories about the mysterious disappearance of PWA. There is a growing, documented truth to these rumors. We know that many PWA have “disappeared” due to abduction, then mutilated and killed by fellow citizens (sometimes family members “friends” or neighbors) for the purpose of witchcraft related rituals.

These ritual attacks frequently find their roots in ancient ancestral beliefs, are a familiar concept to most Africans, and have been going on since time beyond memory.

NOTE 2: Countries known to be involved in the cross-border trade of PWA and their body parts: Tanzania, Burundi, Kenya, DRC, Mozambique, Malawi, South Africa, Swaziland.
